



**Waiver Agreement
Keats Camps**

PARTICIPANT/PARENT/CAMPER RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

Please read carefully.

For Keats Camps and The Convention of Baptist Churches of B.C. (collectively referred to as “Keats Camps”).

In consideration of being allowed to participate in any way in Keats Camps, and its related events and activities, I (We), the undersigned, acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment and personal discipline may reduce the risk, the risk of serious injury does exist; and,
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Releasees or others, and assume full responsibility for my participation; and
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of Keats Camps immediately; and
4. I, for myself and on behalf of my estate, heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless Keats Camps, their directors, officers, officials, members, agents, employees and volunteers; other participants; sponsoring agencies; sponsors; advertisers; and owners and lessors (if any) of the premises used for the activity (“Releasees”), from all liability of any kind for my physical injury, disability, death, or loss or damage to person or property associated with my presence or participation, whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law.

I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.

Finally, I hereby irrevocably consent to authorize Keats Camps to use and reproduce any and all photographs and videos taken of me for any purpose whatsoever, without further compensation to me. All such photographs and videos, including negatives and the like are solely the property of Keats Camps.
